GIRIWAWE LOAN SCHEME FUNDING

Muganga SACCO Secures Funding for GIRIWAWE Scheme

The General Assembly held in April, 2023, resolved to pursue a partnership with the Development Bank of Rwanda (BRD) for the Rwanda Housing Finance Project (RHFP), known as "GIRIWAWE." Subsequently, Muganga SACCO signed a participation agreement with BRD by the end of the year 2023.

Following successful negotiations, the Development Bank of Rwanda has approved an initial line of credit for Muganga SACCO. This initial investment demonstrates the BRD's confidence in our project, with the potential for further funding as the program progresses.

To ensure transparency and member approval, the Board of Directors convened an extraordinary General Assembly in May 2024.

During the assembly, delegates were informed of the agreement with the BRD and certain requirements stipulated by the bank. These requirements received the full backing of the assembly through passed resolutions. The GIRIWAWE loan is poised to revolutionize mortgage loan access for our members.

This innovative scheme offers higher loan amount to borrow, low interest rate, and extended repayment period up to 20 years.

We extend a warm welcome to the elected independent directors. Their valuable perspectives and experience will undoubtedly contribute significantly to the continued success of Muganga SACCO.


